

**REGISTRATION FORM
SCHOOL YEAR PROGRAM 2010/2011**

All students are required to pay a \$15 non-refundable Registration Fee. This is to be paid at the time you register for classes. Tuition may be paid for the full year or in monthly installments. June's Tuition is ¼ the amount of regular monthly tuition & will be due with May's tuition. Each class receives 37 lessons during the year. Monthly fees are the same whether there are 3 lessons or 5 lessons in a month, as tuition costs have been divided equally over all lessons. **Tuition is due on the 1st of each month. A Late Fee of \$7.00 will be charged if payment is not received before the 15th of each month.** All fees are on a per student basis.

** ½ hour specialty classes are only available to dancers enrolled in a separate 1 hour class.

- Classes Marked * are 1hr & 15min – add \$10 to reg. 1hr mthly fee
- Classes Marked ** are 1hr & 30min – add \$20 to reg. 1 hr mthly fee

Family Discount: Deduct \$5 for each additional student, after the first in the family.

Pay just the \$15 registration fee to hold your place in the classes you desire.

COSTUME FEES

Costumes for the December, March & May dance recitals are ordered & purchased in October. The Studio is required to pay for costumes up-front. For this reason, all Pre-ballet, Jazz, Hip Hop & Tap & Creative Ballet classes have a \$100.00 Costume Deposit & most classes will receive two costumes for this price. Classical Ballet classes will only need one costume for the May recital; therefore, the Costume Deposit is \$75.00.

If the costumes cost less than expected, credit will be applied to Tuition or refunded in April. If the costumes cost more than deposit amount, you will be billed for the balance in April. (We cannot control Manufacturers' fees, so this deposit is an estimate based on previous costs.)

Note: Teams I, II, & III have different payment requirements for costumes and will be informed.

TUITION PAYMENT AGREEMENT

I understand that I am responsible for a non-refundable costume *deposit* of **\$100.00 per class (\$75.00 for Classical Ballet), due by October 1, 2010. Costumes not paid by this date will not be ordered and a \$20.00 charge per costume** will be added to cover manufacturer's shipping & handling for separate orders.

I understand that I will not receive monthly bills and that I am fully aware of my financial obligation upon signing this agreement.
